- Dependent on 64 Commodities / Stockpiles of 14
- 1956: \$10.4 billion 2016: \$1.2 billion

- Committee on Foreign Investment in the United States
- Reviews Foreign Investment for National Security
- 16 Executive Branch Departments & Agencies
- Companies Voluntarily Notify CFIUS of FDI
- Operates in Complete Secrecy
- President: Final Authority to Approve or Block


